- defining the competences and responsibilities of all job positions and improving the professional qualifications and awareness of employees continuously, through systematic training;
- encouraging employees to lead a healthy lifestyle;
- maintaining high quality of the products from legal sources of supply and remaining in the legal chain during storage and transport;
- meeting the requirements and maintaining the effectiveness of the implemented management systems;
